- 4) If the hire is cancelled after the full balance has been paid then a refund will be issued minus the deposit amount.
- 5) If you are using our kitchen equipment (oven, microwave, fridges, crockery, cutlery etc) you do so at your own risk. The Club accept no liability for any food that has been prepared by a third party.
- 6) Any breakages must be reported on the day and paid for in full
- 7) Only drinks purchased at the Club can be consumed on the premises.
- 8) Vehicles parked on Club Premises are done so at your own risk.
- 9) Under the terms of our Insurance, equipment used on our Premises by a 3rd party (E.g. DJ/Entertainer) must be supported by a valid Public Liability Insurance certificate, a copy of which must be presented on the date of the hire to the Club Official. Failure to do so will result in the 3rd Party not being able to use their equipment.
